Oando Foundation (or "The Foundation") was established in February 2011. The Foundation aims to support the Nigerian Government to meet the Millennium Development Goals to achieve universal primary education.

Mission: To improve the learning environment in primary schools by holistically creating

world-class basic education systems to the community.

Vision; To create a sustainable and successful educational system in Nigeria that educates

and empowers children.

### What we do

At Oando Foundation, our key focus is providing access to world class education to pupils in the adopted public primary schools. We understand that education is the bedrock of any development, therefore, the Foundation focuses on change with education as the key thematic area. The Foundation seeks to create a sustainable and replicable model for learning in all adopted primary schools across the country through its Adopt-A-School Initiative programme which utilises a systematic innovative and multifaceted approach.

The Foundation will form strategic alliances with key Government institutions and Non-Governmental Organisations. Plans are underway to incorporate other foundations in the United Kingdom and the United States.

### Funding

The board of Oando PLC has committed to funding the Foundation's activities with contributions up to 1.5% of the group's profit before tax (PBT) in its first year of operations and 1% PBT annually in subsequent years.

### 1. ANNUAL REPORT

The trustees present their annual report together with the audited financial statement for the year ended 31 December, 2012, which discloses the state of the affairs of the Foundation.

# 2. LEGAL FORM

Oando Foundation (or "The Foundation") was incorporated in Nigeria on 4 February 2011 under the Companies and Allied Matters Act.

# 3. PRINCIPAL ACTIVITIES

The Foundation is a not-for-profit, non-governmental organization with a desire to empowering communities by providing access to world class basic education to Nigerian pupils.

# 4. TRUSTEES' RESPONSIBILITY

The management of the Foundation is vested in a Board of Trustees who is responsible for the preparation and fair presentation of these financial statements in accordance with Nigerian Statements of Accounting Standards and with the requirements of the Companies and Allied Matters Act.

# 9. HEALTH, SAFETY AT WORK AND WELFARE OF EMPLOYEES

In line with the Oando PLC Environment, Health, Security, Safety and Quality (EHSSQ) policy, it is mandatory for all employees to undergo EHSSQ training before resumption. The Foundation places a premium on safety in the workplace and takes all necessary measures, provides support to ensure compliance with all health and safety legislations, policies and laws applicable to the company's business.

#### 10. EMPLOYEE TRAINING

The Foundation is committed to its employees and sees training and development of its employees as priority. To this end, a training curriculum is developed which is based on the competency directory and forms the basis for the individual training plan for the year. Both local and international training courses are available to employees.

### 11. OTHER ACTIVITIES

In 2012, the Foundation provided technical support to various entities within Oando Group including Oando PLC, in the administration of CSR projects such as adoption of schools, renovation of schools, provision of desks and scholarships.

# REPORT OF THE INDEPENDENT AUDITOR TO THE MEMBERS OF OANDO FOUNDATION

# Report on the financial statements

We have audited the accompanying financial statements of Oando Foundation ("the Foundation") which comprise the balance sheet as of 31 December 2012 and the statement of receipts and expenditures, and statement of cash flows for the year then ended and a summary of significant accounting policies and other explanatory notes.

Trustees' responsibility for the financial statements

The Trustee are responsible for the preparation and fair presentation of these financial statements in accordance with Nigerian Statements of Accounting Standards and with the requirements of the Companies and Allied Matters Act and for such internal control, as the trustees determine is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

# Auditor's responsibility

Our responsibility is to express an independent opinion on the financial statements based on our audit. We conducted our audit in accordance with International Standards on Auditing. Those standards require that we comply with ethical requirements and plan and perform our audit to obtain reasonable assurance that the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the trustees, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

#### Opinion

In our opinion the accompanying financial statements give a true and fair view of the state of the foundation's financial affairs at 31 December 2012 and of its surplus and cash flows for the year then ended in accordance with Nigerian Statements of Accounting Standards and the requirements of the Companies and Allied Matters Act and the Financial Reporting Council of Nigeria Act.

# OANDO FOUNDATION STATEMENT OF ACCOUNTING POLICIES

### 1. BASIS OF PREPARATION

These accounts have been prepared on the basis of historical cost convention,

# 2. DEBTORS

Debtors are stated at net recovery values.

# 3. DEPRECIATION

This is calculated to write off the value of the assets over their useful lives at the following rates:

# 4. DONATIONS

Cash donations are recognised as revenue when cash is received. Gifts-in-Kind are valued at market value or reasonable estimates and disclosed in the Notes to the financial statements.

# 5. EXPENDITURE

All expenditure is accounted for on a modified cash basis and has been classified under headings that aggregate all costs of similar nature. Expenditure is recognised:

- when goods or services are received and cash paid;
- when cash is paid in advance to project partners.

# 6. CASH

Cash and cash equivalents comprise cash in hand, deposits held at call with banks and other short term highly liquid investments with original maturities of three months or less.

# 5. CSR ACTIVITIES

The foundation is yet to commence operations. The foundation rendered technical support on the CSR activities undertaken by entities within the Oando group.

### 6. GIFTS IN KIND

In addition to the 1.5% donation which will be contributed to the foundation from 2013, the staff, office space, and other facilities currently being used by the foundation belong to Oando Plc.

### 7. EVENTS AFTER THE REPORTING PERIOD

# i. Incorporation in the UK and USA

Oando Foundation embarked on incorporating foundations in the UK and USA as charities in March 2012 and September 2012 respectively. On August 29, 2013, Oando Foundation US was fully registered as a charity in the USA and granted tax exempt status under section 501(c) (3) of the Internal Revenue Code by the Internal Revenue Service (IRS). Oando Foundation UK was also registered as a Charity under the UK Charities Commission on 4 November, 2013.

### ii. Bank

In October 2013, an account was opened with Guaranty Trust Bank PLC at its Adeola Odeku Branch.

# iii. School Adoption

By December 2013, a total of 47 Schools across 19 states and the FCT were adopted.

## iv. Programme Implementation

In 2013, a number of activities were undertaken by way of the signature project, Adopt–A-School (AAS) Initiative. They include:

# a. Infrastructural Development

Oando Foundation so far has adopted 47 schools across Nigeria (19 States and the FCT) to benefit from the Foundation's holistic programme interventions; and providing access to quality education to 41,377 pupils.

Creating conducive learning environments through infrastructure upgrade is central to our work at the Foundation. In 2013, we completed the renovation of Central Primary School, Bauchi and commenced renovation in Olokun Primary School in Lagos and Zumuratul Islamiyat Primary School (ZI) Ogun State. Periodic repair and maintenance work were carried out in 2 schools in Cross River and Akwa Ibom States

#### b. Scholarship

Oando Foundation has awarded scholarships to 529 best performing Primary six pupils from our adopted primary schools so far. The scholarship supports their transition to secondary school and the award covers tuition (where applicable) and sundry expenses, subject to excellent academic performance.

c, Early Childhood Care and Development (ECCD) Centres

Oando Foundation works to invest in young children and create a strong foundation for their lifelong health, education, and productivity. Our ECCD centers target the 2-5 age group. We completed our pilot ECCD centre in Archbishop Taylor Primary School, Lagos in December 2013.

## d. ICT/Creative Centres

In December 2013, the Foundation completed its pilot ICT Center in Archbishop Taylor Memorial School, Lagos which boasts of 10 desktop computers, 1 laptop, computer tables and chairs, 1 projector/screen, 1 printer, 1 TV, and 1 DVD Player. All appliances will be powered by solar energy.

ICT classrooms will enhance the learning capabilities of students; facilitate their exposure to computer education and other technologies while allowing students get connected with rest of the world via the use of the Internet.

# e. SBMC Capacity Building

In 2013, Oando Foundation partnered with the UK Department for International Development (DfID) Education Sector Support Programme in Nigeria (ESSPIN) to jointly implement trainings for School Based Management Committees (SBMCs).

We commenced the first phase of training for SBMCs in 16 adopted schools across Lagos, Enugu, Kwara, Kaduna, Akwa Ibom, Edo and Ogun States. The training which was based on identified areas of need provided participants with relevant skills and competencies necessary to improve the quality of education at the community level, enhance access to education, and strengthen local systems of school governance.
